1. ENTRY FEES

Competitors: US\$20-00 /R140-00 per weight/age category

2. ELIGIBILITY

- All players/coaches/officials must be registered with their Federation prior to the commencement of the tournament.
- Passport/ID book must be available at accreditation
- One entry per weight/age category per country
- National Passport holders ONLY

3. COMPETITION RULES

- Competitions are conducted in accordance with the IJF Refereeing Rules
- Duration of Contest :
 - * Junior (U/20) Male & Female : 4 minutes
 - * Senior Male & Female : 5 minutes
- For 5 entries or less – Round Robin
- Categories may be combined depending on entries

4. DEADLINE DATES

- Individual by numbers : Not later than 10 August 2010
- Final entry by name : Not later than 25 August 2010

5. REGISTRATION

- Accreditation will take place at the Portuguese Hall, Vanderbijlpark on Friday, 24 September 2010.
- Upon arrival each Team Manager/Coach should report to the Accreditation station and confirm their entry
- Each delegation will provide their own flag and a copy of their Anthem on registration

6. VISA

In order to ensure the smooth issuance of visas, each country/region is asked to contact the nearest South African Embassy or Consulate for the necessary paper work and begin proceeding at least 1 month prior to departure.

Each country is also asked to pay attention to the validity of the passport for each delegation member. (It must be valid until the date of re-entry into each country).

7. WEIGH-IN

The weigh-in will be carried out in accordance with the IJF rules.

8. JUDO GI

The wearing of a blue judogi when drawn to fight "white" will not be permitted. It is recommended that only white judogis be used. If competitors wish to fight in blue judogi they MUST also have a white judogi.

9. INSURANCE

All participants are responsible for their own insurances as to personal injury or loss/damage of property. Neither the South African Judo Federation nor any of the organising Committees will be liable or responsible insofar.

10. CEREMONIES AND AWARDING

Opening	:	Saturday, 25 September 2010
Awards presentation Ceremony	:	Immediately after the last final and first, second, third place winners are awarded with gold, silver and bronze medals

11. TRANSPORTATION

Each national federation is responsible for its transportation and domestic flight to OR Tambo airport as well as transportation to and from accommodation and venue.
